Subject: Furnishing of Information to the Registration Officer by Nursing Institutions Admitting Foreign Nationals under “Immigration and Foreigners Act, 2025” – Submission of Form II and Form III – Reg.

Reference is invited to Letter No. 25022/28/2020-F.I dated 11.12.2025 issued by the, Ministry of Home Affairs, (Government of India) regarding enactment of a new single consolidated legislation on “Immigration and Foreigners Act, 2025” & furnishing of information to the Registration Officer of Foreigners by educational institutions admitting foreign nationals vide Notification no. G. S. R. 596(E) dated 1st September, 2025 (copy of the Gazette Notification ‘Immigration and Foreigners Act, 2025’ is available in the link below: [https://egazette.gov.in/\(S\(ktcbbp5quipsbz2q3ctr2bg\)\)/ViewPDF.aspx](https://egazette.gov.in/(S(ktcbbp5quipsbz2q3ctr2bg))/ViewPDF.aspx))

In accordance with the provisions of ‘The Immigration and Foreigners Act, 2025’ and the rules framed thereunder, it is hereby directed that, all Nursing Institutions found suitable by Indian Nursing Council and admitting foreign nationals including Overseas Citizens of India (OCI) Cardholders for academic programmes, clinical training, internship, research, exchange programmes, or temporary registration etc shall ensure strict compliance with the following:

1. Every Nursing Institution admitting foreign nationals, including OCI Cardholders, shall furnish complete and accurate information electronically in respect of foreign students enrolled in their institutions through the designated online portal or mobile application as referred to in sub rule (1) of rule 12 of the Gazette Notification as mentioned above with in the period mentioned therein on the mobile application namely, “Indian Visa Su-Swagatam” & designated online portal: <https://indianfrro.gov.in> Info to be submitted to the concerned Registration Officer/Foreigners Regional Registration Office (FRRO)/Foreigners Registration Office (FRO) as applicable in the prescribed Form II (copy enclosed).

2. In addition, Nursing institutions providing hostel or accommodation facilities shall also ensure submission of the prescribed **Form II (earlier Form A)** and **Form III (earlier Form C)** in respect of all foreign nationals including OCI Cardholders.

3. The **Head of the Institution/Principal** shall be personally responsible for ensuring the timely submission, accuracy of information, and continued compliance with the statutory requirements throughout the period of study, training, internship, research, or stay of the foreign national.

4. Any failure to comply with the above provisions shall be viewed seriously and may invite action under the applicable provisions of the **Immigration and Foreigners Act, 2025**, the rules framed thereunder, and any other applicable laws.

All Nursing Institutions are therefore directed to ensure strict and continuous compliance with the above statutory requirements.

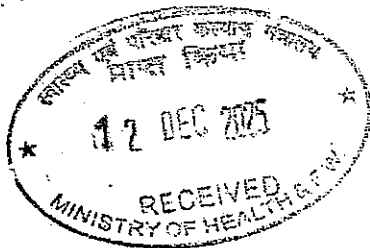

Sub: Information to be furnished to the Registration Officer by every University and Educational Institution including school or any other institution, admitting any foreigner - Submission of Form-II regarding

I am directed to say that the Government has enacted a new single consolidated legislation on foreigners and Immigration "**The Immigration and Foreigners Act, 2025**". The Government has also notified the Immigration and Foreigners Rules, 2025, vide Notification No. G.S.R. 596(E), dated 01.09.2025. This new Act has come into force w.e.f. 01.09.2025. Thus, the Passport (Entry into India) Act, 1920; The Registration of Foreigners Act, 1939; The Foreigners Act, 1946 and The Immigration (Carriers' Liability) Act, 2000 stands repealed.

2. Section 9 of the Immigration & Foreigners Act, 2025, stipulates that every University and Educational Institution or any other institution admitting any foreigner shall furnish information to the Registration Officer in respect of such foreigner in such manner as may be prescribed.

3. Rule 16 of the Immigration and Foreigners Rules, 2025 stipulating that every University and Educational Institution including school or any other institution, admitting any foreigner, including an Overseas Citizen of India Cardholder, shall furnish to the Registration Officer electronically, the information in respect of foreign students enrolled in their institution in Form II through the designated online portal or the mobile application as referred

to in sub-rule (1) of rule 12, within the period mentioned therein and this shall be in addition to the Form III to be submitted in respect students provided with accommodation in a hostel.

4. Form-II is a crucial piece of document, required under the Immigration & Foreigners Act, 2025 and the Immigration and Foreigners Rules, 2025, to comply with Indian Immigration laws and also to ensure national security. Therefore, keeping in view the sensitivity and importance attached to the requirement of Form -II [erstwhile Form - 'A'] for complying with Indian Immigration laws, while also supporting national security efforts, it is requested that the above instructions may please be noted for compliance. This may suitably be brought to the notice of all concerned for strict compliance. (These instructions may also be given wider publicity through audio and visual means and disseminated through FRROs/FROs/Civil and Police authorities in all States/Union Territories to all such Universities and Educational Institutions including school or any other institution, for strict compliance.

5. In case of failure/violations of the provisions of the Immigration and Foreigners Act, 2025 and the Rules and Orders made therein, it is requested to take suitable actions under extant laws/regulations including the Immigration and Foreigners Act, 2025, read with the Immigration and Foreigners Rules, 2025.

6. This issues with the approval of the Competent Authority.
